Crew is being careful with the grading to avoid making mud or damaging the roads. Main roads have been graded; secondary roads have been started. Crew continues to address frost boils and blown down trees. A sinkhole developed on Wiljala Road due to a damaged culvert. A larger culvert is scheduled to installed.

Council requested a bylaw be drafted and presented regarding beaver dams on private property which cause damages to public roads.

A turnaround shall be installed on Maxwell Rd N. to assist with winter maintenance activities.

#### 8 NEW BUSINESS

### 8.1. Aging and Health Seminar Series – Project Debrief

The Township of Conmee was the successful recipient of \$14,984.34 under the 2022-2023 Seniors Community Grant Program. The Township received \$11,987.00 in October 2022 to put towards our Seminar Series project. The breakdown of the spending was provided to Council. The final report has been sent to the Ministry of Seniors and Accessibility for review. A total of 133 people attended with a 99% satisfaction rating.

For the Seminar Series, the Township of Conmee has won the E.A. Danby Award from AMCTO, in the category of "Implementation of Legislation" because of its commitment to making resources accessible to our rural residents and their neighbours, promoting an age friendly community, getting seniors connected (therefore reducing psychosocial isolation), and helping them to age in place. The Award will be presented at the AMCTO Conference in Niagara Falls in June.

Councillor Arnold expects to be in the Niagara Falls around that time. Council approved Councillor Arnold's attendance at the presentation ceremony as a representative of the Township for receiving the award.
