# 7.1. Clerk's Report

The 'conmee.com' domain was renewed for another two years (\$25 a year). Council requested the cost of purchasing and possibly moving over to the 'conmee.ca' domain. The insurance company will be providing free training to staff and council regarding risk management. Date to be determined later. Since the Township has received the reimbursement of its costs for the Spring 2022 flooding, Council agreed to terminate the state of emergency. The Mayor made the following declaration:

I, Mayor Sheila Maxwell, hereby declare an Emergency terminated in the Township of Conmee in accordance with the Emergency Management and Civil Protection Act 1900, s.4(1( due to the emergency described herein:

Spring 2022 flooding

It was noted that interest still remains for a possible skate park in the Township. The Deputy Clerk-Treasurer shall research potential grants or funding albeit for smaller, more scaled-back skating activities.

### 7.2. Public Works Report

An entrance was installed on Lundstrom Rd for a private property. Two turnarounds are in progress. Agreements have been obtained by the property owners. There has been a request from Tbaytel to remove lines from the hydro poles on Olson Road and bury the lines in the ground. The Public Works Manager had no concerns with the request. For the upcoming winter season, the Public Works Manager was granted permission to park the Conmee public works truck at his residence to improve response time for emergencies.

The Deputy Clerk-Treasurer reported on routine activities she conducts to support the office staff.
