 - 7.1.1. SASI Water Treatment quote

Emergency Management Ontario (EMO) has confirmed that the Township has achieved its 2023 annual compliance for all elements required under the Emergency Management and Civil Protection Act (EMPCA). The 2022 and 2023 Energy Consumption reports were filed with the Ministry of Energy. The Township's current "Conservation and Demand Management Plan" must be reviewed by July 2024. The purpose of the plan is analyze energy consumption and identify "energy conservation and efficiency" goals and objectives. The Clerk shall provide a report at a later date. Councillor Arnold requested a delegation with Minister Calandra (MMAH) regarding senior housing and Pines on Hume project. He has requested the Clerk attended the delegation with him. The delegation has not been confirmed yet.

Community Emergency Preparedness Grant:

An updated quote was received from SASI for the updated water treatment system. A copy was attached for council review. Quotes are still being obtained for the two generators. Other items such as the marquee and the cell phone booster have remained at the original quoted prices.

Facilities:

The local school requested approval to borrow the 'good' tables for a graduation reception. Current policy is that such equipment is not rented out. The old tables in the Quonset are available but are certainly not nice enough for a graduation reception. Council agreed that the school was permitted to borrow the 'good' tables at no cost in recognition of the many Conmee children that attended the school. Mayor Maxwell agreed to oversee the borrowing and returning of the tables. Interviews are being scheduled for the two vacant positions. The HR Assistant may have more to report.

7.2. Public Works Report

Maintenance activities included grading and culvert steaming. Brushing is currently on hold. GeoTabs were installed in two of public works vehicles so that pertinent information is available if needed. Brandt was scheduled to conduct the End of Warranty inspection and full service on the grader at the beginning of May. Wolfe Rd was inspected – it is in an acceptable condition for seasonal low-volume traffic; currently no building permits submitted for this road. Budget discussion to be scheduled at later date; proposed capital projects shall include calcium application and road rehabilitation. A box of stingers was purchased for the grader; the public works used 1.5 boxes over the last 4 years.

7.3. Fire Chief's Report

Weekly training continued. The wildland suppression trailer was moved from the garage to the middle bay of the main station to allow for a faster response to wildland situations. An Acting Deputy Fire Chief was selected from the volunteers: Daryl Perfeniuk. Council passed a resolution to approve his appointment; an appointment by-law shall be provided at the next council meeting. Cameras and locks have been installed. Repairs are needed for the pumper; currently being arranged. The Fire Chief has a meeting the previous week with Fire Chiefs from Oliver-Paipoonge, O'Connor and Neebing regarding any proposals regarding potential shared services. Further discussion is required. An application was submitted for the Tbaytel for Good grant to purchase a battery operated multi-tool for auto extrication.
